## PURPOSE

Section 101.6 of the California Business and Professions Code (B&P Code) requires that the California Acupuncture Board (Board) establish that each applicant for an acupuncture license possesses the minimum level of competence necessary for safe practice. Accordingly, candidates must meet the educational and experience requirements set forth in B&P Code Section 4938 and CCR Section 1399.434 and take and pass a written examination that measures the competencies necessary for independent practice.

## EXAMINATIONS BY PSI

The Board has contracted with PSI to conduct its examination program. PSI provides examinations through a network of computer examination centers in California and twenty-two additional nationwide sites.

## EXAMINATION SCHEDULING PROCEDURES

Once you have been approved for examination by the Board, you are responsible for contacting PSI to schedule an appointment to take the examination. You may schedule the examination via the internet at <https://test-takers.psiexams.com/caacupuncture>, or by telephone at (877) 392-6422.

The PSI examination centers are open for testing during normal working hours of 8:00 a.m. to 5:00 p.m. Monday through Friday, and operating hours on Saturday, except for the following major holidays:

## INTERNET SCHEDULING

For the fastest and most convenient examination scheduling process, PSI recommends that you register for your examinations using the Internet. You register online by accessing PSI's registration website at <https://test-takers.psiexams.com/caacupuncture>. Internet registration is available 24 hours a day.

Log onto PSI's website and select Sign in / Create Account. Select Create Account. You are now ready to pay and schedule for the exam. Enter your zip code and a list of the testing sites closest to you will appear. Once you select the desired test site, available dates will appear.

## TELEPHONE SCHEDULING

Call PSI at (877) 392-6422, Monday through Friday between 4:30 a.m. and 7:00 p.m., or Saturday-Sunday between 8:00 a.m. and 2:00 p.m., Pacific Time, to schedule your appointment for the examination. Scheduling services are also available via our Telecommunications Device for the Deaf (TDD) by calling (800) 735-2929.

## CANCELING AN EXAMINATION APPOINTMENT

You may cancel and reschedule an examination appointment without forfeiting your fee *if your cancellation notice is received two (2) days prior to the scheduled examination date*. For example, for a 9:00 a.m. Monday appointment, the cancellation notice would need to be received before 9:00 a.m. on the previous Saturday. To cancel or reschedule, call PSI at (877) 392-6422.

**Note:** A voicemail or email message is not an acceptable form of cancellation. You must use the PSI Website or call PSI and speak directly to a Customer Service Representative to cancel or reschedule your examination and not forfeit the fee.

## MISSED APPOINTMENT OR LATE CANCELLATION

If you miss your appointment, you will not be able to take the examination as scheduled. You will forfeit your examination fee if:

- You do not cancel your appointment 2 days before the scheduled examination date;
- You do not appear for your examination appointment;
- You arrive after examination start time;
- You do not present proper identification when you arrive for the examination.

## EXAMINATION SITE CLOSING FOR AN EMERGENCY

In the event that severe weather or another emergency forces the closure of an examination site on a scheduled examination date, your examination will be rescheduled. PSI personnel will attempt to contact you in this situation; however, you may check the status of your examination schedule by calling (877) 392-6422. Every effort will be made to reschedule your examination as soon as possible, and you will not be penalized. You will be rescheduled at no additional charge.

**Physical or mental impairment** means: (i) any physiological disorder or condition, cosmetic disfigurement, or anatomical loss affecting one or more body systems, such as: neurological, musculoskeletal, special sense organs, respiratory (including speech organs), cardiovascular, reproductive, digestive, genitourinary, immune, circulatory, hemic, lymphatic, skin, and endocrine; or (ii) any mental or psychological disorder such as intellectual disability, organic brain syndrome, emotional or mental illness, and specific learning disability. Id. § 35.108(b)(1).

On the day of the examination, you must arrive at least 30 minutes prior to your scheduled appointment time. This allows time for check-in and identification verification and provides time to familiarize yourself with the examination process. If you arrive late, you may not be admitted to the examination site and you may forfeit your examination registration fee.



## REQUIRED IDENTIFICATION AT EXAMINATION SITE

To enter the examination room, you must present one form of current photo identification. Please note that expired or temporary identification will NOT be accepted. Approved photo identification includes:

- A photographic Driver's License (any state)
- State identification card (any state)
- U.S. military identification
- U.S. government-issued passport booklet
- U.S. government-issued passport card
- Permanent Resident card (green card)
- Certificate of Naturalization
- U.S. government-issued EAD card

*No candidate will be admitted into the examination without presenting one of these forms of identification.*

*All photographs must be recognizable as the person to whom the identification card was issued. The name on the application must match the photographic I.D. card. If you have recently changed your name with the Board, you may want to contact PSI to verify that they have the correct name on file.*

If you cannot provide the required identification, you must call the Board at (916) 515-5200 at least 3 weeks prior to your scheduled appointment to arrange a way to meet this security requirement.

*Failure to provide all of the required identification at the time of the examination without notifying PSI is considered a missed appointment, and you will not be able to take the examination, and your fee will be forfeited.*

## CALIFORNIA LAW SECURITY PROCEDURES

Section 123 of the California B&P Code states: It is a misdemeanor for any person to engage in any conduct which subverts or attempts to subvert any licensing examination or the administration of an examination, including, but not limited to:

- Conduct which violates the security of the examination materials;
- Removing from the examination room any examination materials without authorization;
- The unauthorized reproduction by any means of any portion of the actual licensing examination;
- Aiding by any means the unauthorized reproduction of any portion of the licensing examination;
- Paying or using professional or paid examination-takers for the purpose of reconstructing any portion of the licensing examination;
- Obtaining examination questions or other examination material, except by specific authorization either before, during, or after an examination; or
- Selling, distributing, buying, receiving, or having unauthorized possession of any portion of a future, current, or previously administered licensing examination.
- Communicating with any other examinee during the administration of a licensing examination.
- Copying answers from another examinee or permitting one's answers to be copied by another examinee.

- Having in one's possession during the administration of the licensing examination any books, equipment, notes, written or printed materials, or data of any kind, other than the examination materials distributed, or otherwise authorized to be in one's possession during the examination.
- Impersonating any examinee or having an impersonator take the licensing examination on one's behalf.

Nothing in this section shall preclude prosecution under authority provided for in any other provision of law. In addition to any other penalties, a person found guilty of violating this section shall be liable for the actual damages sustained by the agency administering the examination not to exceed ten thousand dollars (\$10,000) and the costs of litigation.

All candidates will be required to sign a security agreement prior to being admitted into the examination room. Any candidate found in violation of the B&P Code, Section 123, may be held liable for damages and litigation costs and may be denied a license to practice acupuncture.

## IMPORTANT INFORMATION ABOUT TAKING AN EXAMINATION

1. All candidates will have their thumbprint taken during examination check-in. The thumbprint must be matched after candidates return from a restroom break and any time the candidate leaves and returns to the test site after check-in.
2. The temperature in the testing room is maintained at a moderate level. Candidates are advised to layer clothing. Acceptable layered clothing includes lightweight shirts, sweaters, and pullovers without pockets or hoods. These items must be worn upon check-in, while you wait to enter the testing room, and during your initial seating for the examination. If the layered item is removed during the examination, you will be required to store it in the lobby while time continues to count down on your examination. Outerwear (coats, heavy jackets, vests, shawls, scarves, etc.) is not allowed in the testing rooms.
3. There are timing mechanisms available in the testing room and on the computer console to help candidates keep track of time during the test administration. Candidates are not permitted to bring watches or other timekeeping devices into the testing rooms.
4. Only one candidate will be allowed to take a restroom break at a time. Candidates are required to sign out when leaving and returning to the testing room. If a candidate's restroom break takes longer than 5 (five) minutes, a proctor will check on the candidate and will notify the applicable regulatory entity of the occurrence. The regulatory entity will investigate and take appropriate action. Candidates may not leave the building during the examination or while on a restroom break.

\*\*\*Jewelry that is allowed into the examination room is subject to inspection.

\*\*\*\*Drugs that are medically necessary during the pendency of the examination may be brought into the examination site, in a container bearing a proper prescription label with the name of the candidate and of the drug; any such medication is subject to examination by a proctor upon check-in.

Examination proctors will have considerable discretion to refuse permission of clothing and/or items that compromise the integrity or security of the examination.

During the check-in process, all candidates will be asked if they possess any of the prohibited items, and all candidates will be asked to empty their pockets. If prohibited items are found during check-in, candidates must return these items to their vehicle or other place of safekeeping. Neither PSI nor the Department of Consumer Affairs will be responsible for the items. Any candidate possessing prohibited items in the testing room will have their examination results invalidated, and PSI will notify the appropriate regulatory entity of the occurrence.

- Shoes must be worn at all times, and feet are not permitted on the chairs. Feet must remain on the floor during examinations.
- Copying any portion of the examination content by any means or communicating examination content for the purpose of aiding its unauthorized reproduction, whether before, during, or after the examination, is a violation of PSI security policy and existing law. Either one may result in the disqualification or invalidation of examination results, the denial of your license, and criminal prosecution.
- If a candidate is asked by a proctor to step into the lobby during your examination, the proctor will suspend the candidate's examination, so all remaining test time will be retained.

Only candidates, and those individuals with prior regulatory entity approval, are allowed to be present in the testing sites.

If candidates require that an exception be made to ANY of the abovementioned security procedures, candidates must contact their regulatory entity PRIOR to the date of their examination. The regulatory entity must provide the exception to PSI. NO EXCEPTIONS WILL BE MADE ON THE DAY OF THE EXAMINATION.

## TAKING THE EXAMINATION BY COMPUTER

The examination will be administered via computer. You will be using a mouse and computer keyboard.

### IDENTIFICATION SCREEN

You will be directed to a semiprivate testing station to take the examination. When you are seated at the testing station, you will be prompted to confirm your name, identification number, and the examination for which you are registered.

### TUTORIAL

Before you start your examination, an introductory tutorial is provided on the computer screen. The time you spend on this tutorial, up to 15 minutes, DOES NOT count as part of your examination time. Sample questions are included following the tutorial so that you may practice answering questions and reviewing your answers.

### TEST QUESTION SCREEN

The "function bar" at the top of the test question screen provides mouse-click access to the features available while taking the examination.



One question appears on the screen at a time. During the examination, minutes remaining will be displayed at the top of the screen and updated as you record your answers.

## EXAMINATION DEVELOPMENT

The acupuncture licensing examination is developed in accordance with the legal and technical guidelines for producing a valid examination. The entire examination process occurs under the direction of test validation and development specialists.

Examination development begins with an occupational analysis. The occupational analysis is a study of the profession that identifies the critical tasks performed at entry level and

the knowledge required for safe and effective performance of those tasks. The results of the study provide the examination outline, which specifies the content areas of the examination and the weighting of each content area. All content and associated weighting are in direct proportion to the importance of each area in overall practice.

Examination development is a group process, conducted in structured workshops comprised of subject matter experts (SMEs). SMEs are licensed practitioners who are currently practicing acupuncture and are representative of the profession in terms of important demographic characteristics. Each SME provides a different perspective of the profession that might not otherwise be considered by individuals working alone. To ensure that the examination items (questions) reflect the tasks of practitioners entering the profession, each workshop always includes some newly licensed practitioners.

During each workshop, SMEs are trained in the technical, professional, and legal standards that serve as specific guidelines for the development of licensure examinations. Under guidance of a test specialist, SMEs perform different tasks including linking questions to the examination outline, writing new questions, reviewing and revising questions, constructing a new examination version, and determining a passing score.

## PASSING SCORE

The passing score for the examination is determined by a criterion-referenced methodology whereby the passing score is established based on the minimum standards for competent practice and the difficulty of the examination. The criterion-referenced method produces a passing score that is fair to all candidates, regardless of the form of the examination administered.

Setting the passing score is a group process and requires the participation of licensed practitioners. The practitioners who participate in this process are selected to ensure representation of the different aspects of practice. Because the focus is on measuring the level of competence needed for entry into the profession, the passing score workshop always includes several newly licensed practitioners.

During the first phase of the workshop, the minimum acceptable level of competence for safe practice is established and discussed in detail. The panel of practitioners develops definitions of different levels of candidate performance by identifying critical work behaviors that contrast the highly effective, the minimally competent, and the ineffective candidate. Participants are then trained in the procedures used to set the passing score.

By establishing a criterion-referenced passing score, each candidate's score is compared to the passing score or criterion and not to the performance of the group. This comparison will determine whether the candidate passes or fails the

examination. The passing score may vary based upon the difficulty of the items within the examination.

## EXAMINATION DETAILS

The examination consists of 200 multiple-choice questions. You will have five hours to complete the examination. One hundred and seventy-five of these items will be scored; 25 items will be pretest items and will not be counted toward candidate scores. Pretest items will be interspersed with scoreable items, and candidates will not know which items are pretest. This is a common testing practice to test item performance.

Read each question on the examination carefully. Choose the single *best* answer for each question.

*Be sure to manage your time effectively so that you have enough time to answer all of the test items. Items that are blank will be scored as incorrect.*

### EXAMINATION RESULTS

At the end of your test, a printed pass or fail result will be provided. Numerical (raw) scores are not provided.

### FAILING SCORE REPORTS

A percentage score will be provided in each section in which a candidate is deficient. This is intended to guide candidates in areas requiring additional preparation for retesting.

## EXAMINATION CONTENT

The examination covers four content areas that reflect the current competencies in the practice of acupuncture in California. The four content areas are:

1. Patient Assessment
2. Diagnosis and Treatment Planning
3. Treatment
4. Professional responsibilities

Appendix A provides a summary of the examination outline. Appendix B provides several sample questions from each of the content areas.

### *Examination Pulse List*

Several items on the examination will contain descriptions of pulse characteristics or will require you to choose the correct pulse characteristic based on information presented in the items. These items will contain only the English names as described in the New Essentials. Appendix C provides a list of New Essentials terms that describe pulse characteristics that may be used on the examination.

### *Examination Point List*

Several items on the examination will contain descriptions of point locations or signs and symptoms for point prescriptions. Appendix D provides a list of the nomenclature used to identify the points.

### *Examination Single Herb List*

Several of the items on the examination pertaining to herbal medicine will contain questions relating to single herbs. Appendix E provides a list of herbs that may be the basis for single herb questions on the examination.

### *Examination Herbal Formulas List*

Several of the items on the examination pertaining to herbal medicine will contain questions relating to herbal formulas. Appendix F provides a list of the herbal formulas that may be used in the examination for the herbal formula questions.
